County Administrator's Report

Ford County Engineer, Jon Halbgewachs presented updates on projects he is currently working on. Jewell Road east of Wright, the existing pavement is failing. Cracks across the roadway are sinking creating a rough ride. He had taken core samples and Kirkham Michael has completed its review on the samples. A cost effective method of reconstruction would be to mill up the existing asphalt, mixing the chips into the underlying soil with the addition of cement powder, and then pave new asphalt on top to do this to the 18 miles of Jewell Road east of Wright is estimated to cost between \$4.5 million and \$5.5 million (\$250,000 to \$300,000 per mile) this would be good for a 30 year design. Mulberry Creek Truss: He has meet with one landowner, Mr. Wayne Keller to review the preliminary layout of the new bridge. The other landowner Mr. Hawes was not available so he will set up a time to meet with Mr. Hawes the first part of June.

Compass Behavioral Health-Emergency Solutions Grant

Renee Geyer and Nichole Butler with Compass Behavioral Health presented a request for the Commissioners to sign and approve of their application for Emergency Solutions Grant. This grant will be used to provide essential services to families and individuals living on the street, to provide essential services and emergency shelters to these families and individuals. Compass is willing to administrate the Emergency Solutions Grant funds internally or retain Great Plains Development to do so.

Commissioner Tasset moved to approve the Chairman sign the certification upon legal counsels approval. Chairman Boys seconded the motion. **Motion carried 3-0.**

Dodge City Days Pins

Nicole Imel form the Register of Deeds office is asking for Brenda Pogue Register of Deeds, permission to purchase 300 Dodge City Days pins for resale to the employees of Ford County at \$3.00 per pin. This has been done in previous years and allows the employees to purchase pins at a \$1.00 discount. Once the pins are sold, the money will go back into the fund they were purchased from.
