 12- Clerical Error
 1- partially count, voted at wrong polling location

Question if to count.

1-Envelope not signed until person came in on 11-13 and signed.
 1- postage stamp bought on 11-5-18 but no postmark

Recommended not to count

110- not registered to vote
 1- no Photo ID
 7- ballots returned late with postmark after election day
 7- envelope not signed at all.
 Total =125

Commissioner Tasset moved to accept the recommended ballots to count. And to count the one questionable ballot with the signature and not count the one without postmark according to the law. Commissioner Snook seconded the motion. Motion carried 3-0. Making the total to be counted 207, and not to be counted 126.

With the addition of the Provisional ballots, the total for the November 6, 2018, election will be 7,164 votes cast.
