Paved Road Resurfacing (102 and 113 Road) – Kirkham Michael is revising the plans for 113 Road between Comanche St and US-50 to extend the 4-lane all the way to US-50 for a late Fall bid, and include a concrete paving alternate. Will be asking for all needed permits.
