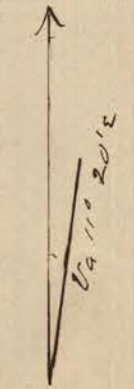

# Memoranda:

The petitioners calling for this survey were as follows: - A. M. Hines, J. E. Mellecker, R. C. Hibbert, L. J. Kuhn, C. E. McKee, Wm. Weiss & T. Frankamp,

As the survey involved Hodgeman Co. I got an order from the Ford Co. Commissioners to establish the County line across Range 21 W.

April 24 1911 was the day agreed upon by A. L. Hull, Co. Sur. Hodgeman Co. Kans., and B. L. Glenn Co. Sur. Ford Co. Kans. but as it rained we met April 25 1911 at the NE corner of T 25 S R. 21 W, and proceeded to establish the line between sec 6-31, 5-32, 4-33, 3-34, 2-35, and 1-36.

I then established the corners of section 5 & 8 as indicated in opposite plat and filed my report May 20<sup>th</sup> 1911

By request of J. E. Mellecker, I set 1/4 sec corner to sees. 6 & 7 and center corner of sec 7 on Mar. 3<sup>rd</sup> & 4<sup>th</sup> 1913. all interested parties were duly notified, Began at the Northeast corner to sec 7 which is an undisputed government corner and chained west between sees 6 & 7 and at 40.00 chs set temporary peg and at 79.15 chs Township line, found corner one mile north and one mile south. From place for the corner on Range line I set the 1/4 sec corner between sees. 6 & 7 and from the four 1/4 section corners I set the center to sec 7. Black lines outline on the plat The expenses \$26<sup>00</sup> have not all been paid
